LD 1 An Act To Establish the COVID-19 Patient Bill of Rights

This law requires health insurance carriers to provide coverage for COVID-19 screening, testing and immunization services and prohibits a carrier from imposing any cost-sharing requirements on consumers for those services. Part A makes it clear that out-of-network providers may not balance bill for those services. Part A also requires providers to provide prior notice to all patients of any payment or upfront charge and the amount of that payment or charge that will be due from the patient for COVID-screening and testing.

Part B authorizes a pharmacist to administer and order COVID-19 vaccines. Part B also requires that health insurance carriers cover a prescription drug prescribed and dispensed to a patient in a quantity sufficient for an extended period of time, not to exceed a 180-day supply, during a state of emergency declared by the Governor, except for certain contraceptive supplies or opioid medications.

Part C allows delegation of authority by an on-site clinician to certain persons for the administration of COVID-19 vaccines at point-of-dispensing vaccine sites.

The law directs the Office of Professional and Occupational Regulation to have its licensing boards issue a license by endorsement to an applicant who presents proof of licensure by another jurisdiction of the United States as long as the other jurisdiction maintains substantially equivalent license requirements for the licensed profession or occupation and the applicant is in good standing.

EMS would like to participate in national quality improvement programs but currently does not have access to the data. Specifically, Maine EMS, hopes to participate in the Cardiac Arrest Registry to Enhance Survival (CARES) Program. The law does not allow the collection of certain sensitive data.

LD 8 An Act To Support Collection and Proper Disposal of Unwanted Drugs

This law requires pharmaceutical manufacturers to establish a take-back program for unused household drugs. Certain retail pharmacies would be obligated to participate as collection sites. As drafted, it appears to try and exclude drugs used at health care facilities from the program it also appears to exclude institutional pharmacies from serving as collection sites.

This law makes two changes to the surprise billing law adopted last year. First, it improves the calculation of the median rate that is used to reimburse out-of-network providers. Instead of the current law, which uses the median rate in the geographic area where the patient resides, it uses the geographic area where the provider is located. Second, the law would allow the superintendent of insurance to use another "independent medical claims" database in situations where the MHDO database is "insufficient or otherwise inapplicable."

The bill also prohibits a carrier from discriminating against a provider based on the provider's license or specialty in a manner that denies payment to the provider for an increase in reimbursement to account for a cost-of-living adjustment.

Current law allows a student covered by an individualized education plan who elected a philosophical or religious exemption from immunization on or before September 1, 2021 to continue to attend school after September 1, 2021 without being immunized as long as certain statements regarding acknowledgement of the risks and benefits associated with the choice to immunize are provided. This bill extends that exemption to any student who elected a philosophical or religious exemption from immunization on or before September 1, 2021.

The amendment changes the requirements for annual reports on the children's mental health program that are submitted to the Legislature and includes data on the number of children served by crisis providers and the number of children who waited for the appropriate level of behavioral health treatment in a hospital emergency room for the preceding year.

LD 119 An Act To Increase Faculty in Nursing Education Programs by Amending the Nursing Education Loan Repayment Program

This bill amends the nursing education loan repayment program in three ways.

- 1. It extends eligibility to apply to individuals who are currently enrolled in master's or doctoral degree programs.
- 2.It specifies that applicants must indicate an intention to work as full-time nursing faculty in a nursing education program in the State, and increases that required commitment from 3 years to 5 years after acceptance into the nursing education loan repayment program.
- 3.It increases the maximum amount of loans eligible for repayment under the program from \$4,500 to \$30,000 for a master's degree and from \$6,000 to \$60,000 for a doctoral degree.

This is a refile of a bill that died at the end of session last year (LD 799). However, this bill is consistent with the bill as filed last year; it is not consistent with the amendment. (Last year's amendment significantly expanded who could qualify for loan forgiveness beyond nurses.)

This law establishes the Office of Affordable Health Care as an independent executive agency and requires that the office provide oversight and staffing to the Maine Prescription Drug Affordability Board. The office is charged with analyzing data from the Maine Health Data Organization and the Maine Quality Forum and making recommendations to the Insurance Committee on methods to improve the cost-efficient provision of high-quality health care to the residents of this State.

The office is required to hold an annual public hearing on cost trends no later than October 1st annually at which the public may comment on health care cost trends. The office is required to submit an annual report. The advisory council consists of 11 appointed members, including a member who represents hospital interests, a member who represents primary care provider interests, a member who represents a health care consumer advocacy organization, a member who represents health insurance interests, a member who represents purchasers of health care, a member who represents the health care workforce, a member who represents the interests of older residents of this State and a member with demonstrated expertise in health care delivery, health care management at a senior level or health care finance and administration. The Commissioner of Administrative and Financial Services and the Commissioner of Health and Human Services are ex officio members of the advisory council.

LD 121 An Act To Require a Background Check for High-risk Health Care Providers under the MaineCare Program

The law gives DHHS the unilateral ability to define by rule the high-risk categories and decide who has to have a criminal history background check. Hospitals are governed by 22 MRSA §1724 which require criminal background checks for employees who have direct access to consumers.

LD 131 An Act To Amend the Governor's Emergency Powers

The bill also provides that a pharmacist may not dispense more than a 30-day supply of a new prescription drug order to a patient who does not have a previous prescription drug order for that drug. The prescribing and dispensing requirements in this bill provide exemptions for opioid medications prescribed or dispensed in accordance with Maine's opioid law.

LD 196 Resolve, To Ensure Access to Community Mental Health Services

This bill restores the ability of nursing facilities to voluntarily reduce the number of their licensed beds and then later increase the number of their licensed beds to the prior level after obtaining a certificate of need and meeting certain conditions. The bill modifies the process to obtain certificate of need approval to reopen reserved beds. Applications that seek to reopen reserved beds must be approved if the projected incremental costs of reopening and operating the reopened beds are consistent with the facility's costs of operating its other beds. Applicants are not required to demonstrate that any increases in MaineCare costs are offset by other MaineCare savings. The costs of ongoing operation of both the restored beds and the complement of facility beds at the time the reserved beds are reopened must be recognized as allowable costs and incorporated into the facility's MaineCare payment rates. The bill requires DHHS to include in its calculation of reimbursement for services provided by a nursing facility the cost incurred by the facility for a medical director. The bill requires the cost incurred by a nursing facility for the acquisition, use and maintenance of computer or cloud-based software systems to be included as a fixed cost.

LD 254 An Act To Allow Certified Registered Nurse Anesthetists To Bill for Their Services

It also removes restrictions related to the technology used to provide services through telehealth.
- 4. It prohibits a carrier from placing any restriction on the prescribing of medication through telehealth by a provider whose scope of practice includes prescribing medication that is more restrictive than any requirement in state and federal law for prescribing medication through in-person consultation.
- 5. It clarifies that the availability of health care services through telehealth may not be considered for the purposes of demonstrating network adequacy.

Part B permits health care providers licensed under the Department of Professional and Financial Regulation to provide telehealth services as long as the licensee acts within the scope of practice of the licensee's license, in accordance with any requirements and restrictions imposed by law and in accordance with standards of practice. The amendment defines "telehealth services" and authorizes licensing entities to adopt rules to establish standards of practice and restrictions for telehealth services.

It provides immunity for good faith acts or omissions by staff, employees or agents of the hospital or residential care facilities for their use of the remote signing process. It does not apply to any other documents or settings or when advance health care directives are notarized.

Beginning in plan year 2027, carriers are required to maintain, at a minimum, the total combined spending on primary care and behavioral health care achieved in plan year 2026. - 3. It transfers rule-making authority pertaining to unemployment insurance from the Unemployment Insurance Commission to the Commissioner of Labor.
- 4. It increases the allowance for dependents and the cap on the allowance for dependents.
- 5. It removes an exemption from the requirement to show good cause for participation in reemployment services and eligibility assessment.
- 6. It provides eligibility for unemployment compensation for a person who leaves employment due to the unexpected loss of child or elder care under certain circumstances.
- 7. It provides that evidence presented at a fact-finding interview by interested parties who personally participate in the interview by telephone or email or other electronic means is permitted for a determination of eligibility for unemployment compensation.
- 8. It specifies additional conditions that trigger an extended benefit period.
- 9. It increases the total extended benefit amount in a high unemployment period.

It establishes the peer navigator program to increase access to unemployment compensation benefits for underserved individuals and makes several amendments in current law to support these goals.

This law appropriates \$1 billion which is Maine's share of the federal American Rescue Plan Act of 2021; with respect to hospitals:

- 1. It provides \$2.5 million for workforce training funding for hospitals and nursing homes;
- 2. It provides \$1 million for nurse faculty loan repayments (the substance of LD 119);
- 3. It provides \$2,000,000 for the Doctor's For Maine's Future Program (the substance of LD 440);
- 4. It provides \$1.6 million for to providers to serve as preceptors and clinical sites for health care 3 students who require clinical hours and related oversight;
- 5. It provides \$80 million to defray unemployment insurance cost increases on business.

The scope of several other workforce and business grant programs in the law is unclear as to whether hospitals may participate. We will provide more information as we learn more.
